Retention levels of Wolf Trax Nutrients on dry fertilizer blends will vary. Factors affecting the retention level include the quality of the dry fertilizer, the level of dust within the dry fertilizer and the presence of liquid additives. As a general guideline, the retention rates of Wolf Trax Nutrients on many common dry fertilizer blends range from 0.3 to 1.0% by weight. Liquid additives may increase the retention of Wolf Trax Nutrients. To determine the coating capacity of Wolf Trax Nutrients on your dry fertilizer blends, always use a blend test and consult a Compass Minerals representative.
